Child Development Programs: We have 10 child development centers in the Early Learning program of Peninsula Family Service, serving about 470 children ages 6 weeks to 12 years. (1) All of our programs operate in collaboration with community partners. (2) Specialized programs include the comprehensive wraparound services provided by Early Head Start, and programs for homeless children and children of teen parents. Children in our programs are encouraged to be a caring, curious, and creative community of learners.

Financial Empowerment Program: Provides low-interest automobile loans for individuals, case management services, support services, including prepaid debit cards, and financial literacy services to low-income parents with custodial children.
